Minutes for Meeting of Friday, *January 18, 2019*:

11:00 am ET - CALL TO ORDER, INTRODUCTIONS AND ROLL CALL:

1. ROLL CALL:

Ed Thomas noted the need to reach out to RNN communities and find out what they need to be more engaged.

- Rebecca Joyce suggested a short survey and will follow up with NHMA Admin.
- Vince Brown to get some FEMA staff to come on the calls and discuss happenings in FEMA.

Ed Thomas working on the ABA book.

Ned Swanberg taking notes until NHMA Admin reconnects to call.

2. APPROVAL OF MINUTES: - TABLED

Quorum not present.

3. Review of Action Items

Ed Thomas reported progress being made on the ABA book:

- Anyone wanting to look at it or make comments are welcome;
- They have significantly changed their approach and will be including material on the Denis Mileti approach as documented in the *Hide From the Wind* report;
- They are looking for specific suggestions on what people should be doing and how they should be doing it;
- Would like to run it past Roger Faris, who was looking for a wildfire author;
 - Could Roger find somebody with specific solutions or examples of what communities have done with regard to wildfire?
 - Might make use of some of the materials we're going to be working on for FEMA;
 - Would like to include any materials that anyone has on information dissemination.

DISCUSSION:

Gene Henry reported that he is now finishing up working nationally with another group.

- One of the things that people are looking at is when FEMA goes in to assist local communities, many times there's no information to assist those communities in understanding the process of stepping into long term recovery, other land uses and zoning.
 - This is what some of our courses are about regarding wildfire, flooding and so on.
- How can we engage better – where there's a response issue for instance, they're looking at the life lines and seeing how people can get back up and running.
 - It would be nice to begin looking at and helping FEMA actually understand all the work that has been performed that they have paid for and get that information into the hands of local planners, administrators and elected leadership about what they can do to make their communities a little bit more resilient early on.
- This could be something that RNN could focus on or at least be referenced in regard to.
- I don't know how to make that happen, I just know that right now a lot of emphasis is being put on the response and having life lines established and FEMA's putting in a lot effort with that, and a lot of effort also into long term recovery, working with us, and such, as well.

Ed Thomas shared that this is actually what we are trying to do with the help of Vince Brown and his management;

- We were putting this together for Florida two months ago for post disaster recovery, but the state decided it was not interested in hearing from us on this.
 - However, we did develop a skinnied-down, post disaster long-term recovery document.
- We could focus on having available RNN Members come in to teach some stuff on exactly what Gene Henry just described on a peer to peer basis going in post disaster.
 - We have picked up a lot of knowledge and experience over the years and can offer some tricks of the trade and show how other people have done it; 'it's an enormous challenge to leadership and here's how it can be done'
- This would be something incredibly worth doing.
 - It is the fundamental basis of the old *Patchwork Quilt* document and is very much along the lines of what we want as an organization.
 - We've worked with Matt Campbell and Michael Gumperg from the FEMA Long Term Recovery Group to try and have that happen.
 - Michael has developed what he at one time called a Curriculum (and now calls something else) which is a sort of very large education of how FEMA does business;
 - The concept of going across silos, about how do we weave in HUD, how do we weave in the foundations, the charities, pulling this all together from the point of view of long-term resilience and recovery.
 - This is a great idea project for RNN and fits into what Ned and Roger Faris are working on in coming up with a vision of how to do stuff; and also what Barb has been working on with Roger Faris on what do you do when there's no disaster declaration;
- So, this is right in our wheelhouse –how do we make that happen?
 - Veronica and Wightman Associates can help us with that - we have some staffing – it doesn't all have to be done by volunteers.

Gene Henry agreed.

- Bob Frietag and a lot of folks have been working on the life lines, then we get lost with do we build, rebuild, etc.
 - Gene Henry has been working with Bob Frietag for years.
- If at the time of the event of a disaster, while folks are getting into looking at their recovery, all the information's there - groups can work with us.
 - if we can show our local communities through RNN or some other means before you have to step into response, but if they knew their areas of vulnerability, both the sustainable vulnerable areas as well as the ones that aren't so sustainable, then we have a whole slew of recommended courses of action from construction to land development and we can just make a recommendation.
- It's just finding some method of delivery saying 'here's your areas of vulnerability and we have the plans at the state and local levels', and you identify the simple techniques and offer a deeper dive into the rest of our materials.
 - If we can add that to our toolbox, then it may help communities initially say 'oh yes, we do have vulnerabilities' in these areas.

Ed Thomas asked the group to continue this discussion:

- Gene's remarks are spot on and fit right into how do we get more folks interest in RNN and wanting to participate.
- This is certainly a potential project for RNN to work with the other volunteers in NHMA - professionals like Roger Faris - and really do something that would be of enormous value to society.

Gene Henry extended remarks:

- Gene shared he just had some sessions with building officials earlier in the week.
 - Because of the state's requirements in having to bring in their codes and compliance, everyone's a little behind, but at least they have something under state statutes they can fall back on.
 - They still have to bring their codes into compliance with the State of Florida building code.
- Gene noticed there's still some confusion, especially from - in their case - the building officials, because they aren't looking over at the Land Development Code, and then a lot of communities are stepping into resiliency, so a lot of updates are occurring without any integrated perspective with the Land Development Code or long-term resiliency or sustainability of these communities.
 - Again, FEMA has worked on both lines – they've helped communities understand their life lines, their mitigation, and they're also helping them do exercises in pre-disaster reviews and such.

- If you went to some of the communities after a disaster when they're saying 'okay, we're having to deal with our damage assessment, we have to get these people in for permitting and review of substantial damages' and so on and so forth, if FEMA *at that point in time could say* 'hey, here's a brochure; this is a good time, especially as you start working on an after-action report, not only do you look at sustaining your life lines and how you can get those back up if they fail while you're in a disaster, everyone understands the construction code, here's some things that you could do and add these items in for Firewise, or No Adverse Impact – and then show them we've got the material - its beautiful.
 - If FEMA could then work with these communities, it opens the door for community networking.
 - Saying, 'if you want to check somebody out and call them, here's the network, these are the standards, and by the way, we helped bring these together so if you are looking to figure out how to make yourself more resilient to these wildfires and then follow up to the flooding in the following season, we have that for you';
- FEMA has it - they pay, they work with NHMA, they work with ASFPM, they work with the International Code folks.
 - We have all the pieces and parts and we've done a great job, and the team under Natural Hazard Mitigation has brought that together very well - so it's already done.
 - What else would FEMA like to see in order to hand that out to communities that are trying to figure out how to work with reconstruction? They all have to renew their codes anyway.

Tom Hughes shared:

- Very glad that Gene brought this up.
- They ran a pilot with a couple of communities in Pennsylvania that got hit really hard in 2011.
 - Tom wanted to do a test of DR4408 in the field with a document exactly like what Gene is talking about.
 - The municipalities are a little overwhelmed with people and with documents, asking what's the checklist?
 - So, Tom and his team actually put together a checklist so communities can sit down and see what to do.
- In his state, they don't have the capacity to sit and talk about substantial damages determinations.
 - They have codes enforcement officers that may not be looking at the flood side of it because they're not even contracted for that.
- So, they didn't do that in 2011. And, like Gene said about the land use - all that has to be tied together, and they actually now have a document that they worked up with the risk in-house people in FEMA Region III, and worked with the Flood Plain Managers and the NHMA, and they will have a document that will talk about everything that Gene Henry just spoke about.
 - The document was recently tried in another state - one of the other communities in the coastal part of Virginia.
 - Tom has been pushing to have it included as part of their strategy: even if the document's not 100%, it's at least 95%, so 'let's get it out there'.

Ed Thomas mentioned:

- One of NHMA's long-term volunteers, Alessandra Jerolleman, has stepped forward and is very interested in re-establishing a monthly webinars series that has languished in NHMA for some time.
 - Might this be a good topic for our first webinar?
- Tom Hughes said that he is still trying to pull the checklist together for approval but will share it with the group once it's okayed.
 - It may be a week or two before it comes out.
- Can we stimulate them a little bit by saying we want to do a webinar on this?
 - Maybe Gene Henry and some other folks can be the presenters – the peer to peer networking of the RNN communities is one of the critical components of RNN and its great advantage.
- Instead of a webinar, can we just have a webex – we could work with the communities and let them have an interaction.
- Ed Thomas clarified that when he said webinar, he really meant interactive webex.
 - Peer to peer interaction with folks being treated as experts - even the ones that don't think of themselves as experts, are really experts on why things aren't happening. They're experts on what impediments they have.

- This would be an incredible resource to have available in short pieces and could easily be folded into the concept of the NHMA Curriculum.

Tom Hughes added with regard to the Ambassador Curriculum:

- There are unofficial people in the community with regard to resilience that have picked up the ball to at least do the legwork – for example, his call two days ago where they had someone who wasn't a zoning official, but went around and took pictures of impacted property for them, and that kind of thing;
 - If the community had a checklist, the officials could just hand it to these folks and magnify their capabilities, even in a rural area – say, a retiree, asking them 'could you do this for me, at night we'll get together and sit down and add that in'.
 - We just want to be able to give communities the basic tools.

Joe Rossi shared:

- On their Board at the Mass Coastal Coalition, they have the Massachusetts American Institute for Architects' Post Disaster Coordinator. Her job is, after an event, she organizes disaster response professionals in the field to do recognition – exactly what Tom was talking about.
 - Joe will ask her if there's a resource she can pull together to do some type of webinar on what we're talking about.

Ed Thomas observed:

- How do we get Gene Henry's idea organized and put into practice?
 - With the work we're already doing in NHMA, hopefully there will be other people available to help carry the load here – 'many hands making light work'.
- We need to convey to Alessandra the concept of doing a webex:
 - To work with Tom to get permission to use this material;
 - And to suggest this as part of our monthly exercise of information dissemination and discussion in the RNN.

Tom Hughes added with regard to the FEMA VOAD program:

- FEMA pays for material and volunteers who actually do the work for repairs.
 - Pennsylvania didn't get a disaster declaration on their recent event but are going to do a state VOAD program.
 - There's money put aside through it to help get people back in their homes.
 - One of the things they noticed is that it would take between 8 and 12 months to try to get somebody bought out.
 - If they're going to spend state dollars toward those repairs, maybe they also need to look at the state harvesting programs.
 - If they put in a furnace or a water heater and invest dollars in that, they're going to see if they can't harvest those dollars back and actually use them for the low-income folks.
 - If FEMA will allow them to buy the homes, once they have a harvesting plan in place they can do it. But it has to be done ahead of time.
 - Getting ahead of the curve right now, they prepared a template for the counties so that they can put the harvesting plan in place for each and every county.

Donna Boyce shared:

- Post Sandy in Sussex County, when they did the Post Satisfaction Survey for the homeowners, that's something they specifically requested.
 - Community support - they were able to consider that.
 - Very glad to hear that this is something that might happen.
- Found that some of the smaller fixes like the water heaters were smaller in size, so if you were thinking to reuse, might that be more toward multi-family units?
 - If you had a townhouse program or something, and maybe work with the HUD offices that do affordable housing programs or get CDFIs?
 - The local VOAD is a nice place to start.
- Tom Hughes observed that her experience in New Jersey could be part of the strategy

- Donna will send Tom Hughes her thoughts on harvesting so he can include New Jersey's experience as part of the template strategy – the greater the integrity of the template, the better.

DISCUSSION:

- Have they done any whole building relocation?
 - Not in Pennsylvania because it's very expensive. They lean more toward demo-rebuild.

Ned Swanberg shared:

- In terms of Vermont, they did recently update some stuff related to FISS on their website for communities.
 - A lot of them don't have much familiarity so they built out a simple procedure and put it on line so that it's basic by default.
 - The way the communities work through FISS - if they choose otherwise ahead of time so it helps with outreach.
- Also, Florida has a very sophisticated package of post disaster materials for communities – it would be interesting to get somebody from Florida to talk about this particular fit and its advocacy.

Gene Henry asked: Can this checklist can be shared with us?

- He would be happy to share it regionally or with peers through their All Hazards Group and the Florida Flood Plain Managers in order to get it out, because:
 - When someone's working 18 hours, and FEMA comes up and says 'listen, did you do your Fed for all those structures you've identified as destroyed?' it would be a great help.
 - In a day any shortcut helps.
 - Maybe we can tweak it up and put it in some brochures and things.
- Vince Brown also requested a link be sent.

Gene Henry remarked:

- His was one of the initial communities for post disaster development.
- He was charged with the Assistant County Administrator to look at their long-term reconstruction plan.
- He had a Planner call around and talk to all the communities that had one. There were less than six.
 - No one fully activated their long-term reconstruction plan; only a few even partially used it, and then only used it for the human needs side. They went back to business as usual when they went back to reconstruction.
- So, that is absolutely right: He found they spent a lot of years working on the long-term reconstruction plan process and it served well for those communities that used it. However, none of them used it to look at full reconstruction.
 - In Gene's case they just had two riverines that were significantly flooded, and they know what they need to do there.
- He understands that they sent contractors down from Monroe County to actually start redeveloping a post disaster redevelopment plan. And sort of in sync with what happened after in 2004, coastal communities had to have post disaster redevelopment plans – they were very poorly done in the early 2000s and late 1990s, and there seems to be an inability to pull up those reconstruction standards and higher standards after the disaster.
- But they serve very well if there are components for human needs and if the regional services and social services are tied into the process.
- That's an over-simplification; but Gene was actually tasked with finding this out for their community because they're stepping in in the coming year or next couple years.
- So that's the reality of folks using their long-term post disaster reconstruction funds.

Ed Thomas asked:

- How can we keep this discussion going?
 - Is the first step to ask Tom to work with through the JFO and work with Alessandra to get this up as a webex?
 - As a discussion for us to get the information from Ned Swanberg incorporated into the ongoing discussion that Traci Sears is taking the lead on in documenting best practices for substantial damage post disaster that she had worked up with Maria Lamb from South Carolina?

- Is that the way forward for us to ask Traci to work with Maria and Ned together on coming up with something simple for other communities along the lines of what Vermont is doing and Montana has done, and South Carolina has done?
- Maybe eventually producing something on sort of a model substantial damage thing for communities to consider post disaster and then have a webex on the discussion that has taken place here?

Tom Hughes to do several Action Items:

- Get together with Alessandra Jerolleman on a webinar / webex to talk about the document and harvesting;
- Get a copy of the checklist document approved to use in the webex;
- Reach out to the states of Illinois and New Jersey for information about their mutual aid for flood plain administrators – they have a team name and responsibilities – to hear how they are able to build capacity for local communities.
- Tom to have these done within the next month.
 - *It will probably take at least 18 months to actually go live.*

Tom Hughes suggested another resource to consider is the use of FEMA Corp folks that come in after a disaster.

- FEMA has resources through FEMA Corp for local folks who may not know to ask. A lot of the states wouldn't even think about using them.
 - His state put them to work in their JFO;
 - In Texas they did a substantial damage determination for the locals there.

Vince Brown suggested adding FEMA's internships for college and high school students as an additional resource.

Ed Thomas observed these are all excellent ideas - this is incredibly good progress today;

- Some potential follow-through from Tom Hughes,
- Possibly incorporating this into an RNN Work Plan as we go forward, as this is what the RNN wants to work on together for the sake of the communities;
- Share this information and get this out which is all along with our vision with respect to the RNN.

Vince Brown suggested holding another meeting to pull this all together:

- Tom Hughes to get with Alessandra Jerolleman to learn her schedule and when she would be available for a follow-on meeting.
- May be able to build a webinar series just based on what we've got on that.

Ed Thomas proposed a friendly amendment that per Gene Henry's suggestion, "webinar" should instead be "webex".

- Veronica Criscitiello to loop in Gina Wightman on all of this as she has been working with Michael Gumpert from FEMA on related topics.
- Vince Brown to get information developed on this and loop in his management who will likely be very interested in what we're trying to do.

Tom Hughes suggested the series that's being written on wildfires in California best practices would be good to have as part of one of these monthly webexes.

- Tom, Alessandra, Veronica, and Gina to loop in Roger Faris and get folks working with Roger.

Veronica Criscitiello reported that Wightman is currently working on the technical assistance post-disaster hand out.

- Asked the RNN for their contributions:
 - Want to get their experience on how does a local community get technical assistance directly:
 - What is the first step after an event?
 - Who do you contact if one is looking for engineering assistance to put together a project or a grant writing effort?
 - Who do you go directly to?
 - Do you go to the state, do you go directly to FEMA?
- If anyone could share their experience, she would like to document it and include it in the technical assistance materials.

Veronica Criscitiello will send out an e-mail on this and people can respond with some bullet items and then perhaps follow up with a phone call for more information.

- NHMA Admin to assist Veronica in getting this out to all RNN members.
- Vince Brown to be included on this so he can socialize the information around FEMA and let folks know that the Grant is working and has produced a group that is doing some wonderful things; whether it's a meeting set up or a whole program, please keep him informed.

Veronica Criscitiello to forward links to Vince Brown on:

- Status update of the DRR Curriculum and the workshops that have gone on;
- Post disaster resource on funding from the NHMA website (skinnied-down version developed for Florida)
 - Send out a copy of the Checklist to the RNN
 - Send out a link to the Checklist to the RNN and to Vince Brown

Gene Henry asked if Ned's checklist can be shared with us?

- He would be happy to share it regionally or with peers through their All Hazards Group and the Florida Flood Plain Managers to get it out.
 - When someone's working 18 hours, and FEMA comes up and says 'listen, did you do your Fed for all those structures you've identified as destroyed?' it would be a great help.
 - In a day any shortcut helps.
 - Maybe we can tweak it up and put it in some brochures and things.
- Vince Brown requested a link.

Ed Thomas gently urged Ned Swanberg to write a brief article on what they are doing in Vermont:

- Just to say, 'This is something we're doing in Vermont, for the purposes of our communities, would like to share this with folks, it's a nice simple checklist and its an approach on substantial damage estimation.'
 - That, and as much info as he would like to write, can then go into Vince Brown's newsletter, into the NHMA Newsletter, and can in turn then go to the Florida Flood Plain Managers and get disseminated far and wide;
- Then feedback can come in to tweak it.
 - This is part of the national conversation we want to have.
 - If Ned could write that short little piece up then we'll put it into the NHMA Newsletter and Gene can take it and run with it and give it to Vince for his newsletter.
 - The CTPS are also always looking for stuff.
 - This is something we can show to FEMA that they're getting something for their investment.
 - Roger Faris is one of the best writers we know, who can look at it and tweak it up a bit if it needs it.

Ned Swanberg to write up a short article about what they are doing in Vermont and include a copy of their checklist as an approach on substantial damage estimation.

- Tom Hughes and Alessandra Jerolleman to incorporate this into the webex series to help people think about how to maximize the opportunity that's presented by horrific natural disaster in their lives.
- Ned Swanberg to send out a link to the Checklist for the RNN and Vince Brown.

4. Wightman & Associates seeking RNN SMEs for the following:

Veronica Criscitiello reported on status of the DRR Curriculum:

- An update on all the Modules was sent out this morning with a full list of the Modules.
- So far, 22 out of 24 are in development:
 - The Wildfire/Flood Connection Module has been sent out for review;

- Traci Sears will look at it as well.
- The Thunderstorm-Tornado Safe Room Module has been sent out for review;
 - This will also be sent to Ken when he returns from his vacation.
- The Leadership Module is in process: we are working on questions.
 - The idea is to get interviews via iPhone videos from different leaders throughout the country who have been 'change champions'.
 - Once we have those questions, we'll send them out to whoever wants to look at them – or who have time to look at them - and provide feedback or can recommend a 'change champion' who would be good to answer those questions.
- We'd love input from the RNN Communities.

Ed Thomas added that part of the Curriculum will be specific items that we can, if necessary, get help from Wightman & Associates on in terms of helping refine them.

- We've had other volunteer services, the directors ongoing webinar series, and hopefully - with the help of Rebecca Joyce and Barb Miller - we're going to have an energized RNN, so this is a very exciting call today.

5. NHMA DRR Curriculum & Workshop Status:

6. Discussion of Best Practices Documentation-New Best Practice on mitigation-based recovery with no Presidential Declaration: Joe Rossi and Coastal Coalition [Material sent separately] and Traci Sears from Montana

Joe Rossi reported on recovery in the case of no disaster declaration:

- He has been appointed to the Silver Jackets Team in Massachusetts.
- One of the efforts that they're working on is bringing this post disaster outreach as part of the Silver Jackets in terms of making it an activity built into what happens after an event occurs.
- The other thing they're doing is trying to solidify the outreach as a standard program.
 - They have currently built a partnership with the Massachusetts Municipal Association, and sometime this year are hoping to present the curriculum that they've put together to their Mayors' Council so every mayor in the state of Massachusetts will see their presentation to make sure that they're aware that their resources are available.
 - In addition to that, they are solidifying this in written form, as ongoing, compiling it together to make sure it can be used as part of the Curriculum that we've talked about here before.

Ed Thomas shared that this information is very exciting.

- Ed has a number of things going on that Joe Rossi and he can talk about separately.
- Ed mentioned that Tom Robison, the head of NHMA's Policy and Public Affairs Committee, will be heading up an effort to prepare suggestions from NHMA with respect to the reform of the National Flood Insurance Program – a very exciting effort.
- Dr. John Wiener will be helping him with this, Jim Murphy will be providing some input as well, and we certainly want to run that effort past Joe Rossi.
- Ed Thomas offered to support Joe Rossi's efforts with the Silver Jackets in Massachusetts when he returns to Massachusetts in April.
 - Ed shared that we spent a huge amount of time working with the Silver Jackets in South Carolina, with the presentations that were done by Tom Hughes and John Marshall and many other folks last July.
 - Ed will be happy to coordinate with Joe Rossi by phone, or upon his return to Massachusetts, with regard to making use of the DRR Curriculum materials in any way that we can incorporate the Massachusetts Coastal Coalition's efforts into our program materials, and also similar materials we've got, with respect to Massachusetts Silver Jackets.

- Susan of NAFSMA may come in; Vince would like to talk to Ed about doing a joint presentation.
- FEMA's Planning Program is setting up an Awards process for giving communities awards for innovative planning processes. This will 'up the game' for the Planning part of FEMA's RISK MAP Program.
- They are going to provide a link to the RNN and newsletter in their Risk Map NewsFlash newsletter which links it directly to NHMA's newsletter.

11. Status of Island Press Interest, Articles for NHMA Newsletter and/or ABA

There are many opportunities to publish articles about what we are doing in resilience.

12. Comments/Issues/Good News

Gene Henry shared that he went with his family to Dallas, Texas on a camping trip.

- While they were there, the campground flooded.
 - Other than the National Weather Service, they didn't have any warning system; nothing came from the city that they were in, which was North of Dallas.
 - While they took their time going to Mississippi and other places, Gene pointed out that the land they drove through was flooded all the way from Dallas, Texas through Mobile, Alabama.
 - A few spots they passed had people in boats tied up outside of strip centers instead of cars.
- Everything that RNN is doing is also applicable to small communities which can use those same techniques to work with their businesses during a disaster.
 - Good techniques and standards that people can use to protect themselves or their customers don't always have to come through the Emergency Management Office or the Planning Office.
- It's remarkable how we're being shared at the National Headquarters and FEMA and such; but everything that's being done is applicable in the smallest community and the smallest little RV park, and there's so much going on, it's truly needed.
- We need to permeate all this information into the hands of people like us in the small communities.

- There is a need for this throughout the nation at all levels but especially in small communities because they don't have the economies of scale to go in there and work with a disaster for years or even months. They have to do something right away, and if its not captured at that point, then the resiliency efforts can't be performed and the response for the customers, for whom we all serve, can't be done very well either.

Ed Thomas agreed that this is a tremendous challenge.

- What Gene Henry is talking about is an enormous challenge that our nation faces in terms of dealing with disasters, emergencies and communicating to small governments. But it is also a challenge to large governments too.
- Ed shared that he has had discussions with some people at pretty high levels of very large and supposedly sophisticated governments and heard just jaw-dropping comments as to their analysis of disaster preparation and preparedness.
- NHMA Admin to write up what Gene's remarks.

13. Adjourn

Ed Thomas gave particular thanks to Ned Swanberg who agreed to pick up the Minutes when NHMA Admin couldn't get back on the line.

- Great reports from everyone.
- It looks like we have the beginnings of a wonderful work plan.
- Liked what Gene Henry laid out as a challenge and suggested we should incorporate that into the RNN Mission.
 - Meeting that information need on a peer-to-peer basis is what the RNN and NHMA are all about.

Vince Brown to speak to Ed Thomas and talk about who he can round up for a presentation or presentations to his people.

- A19: - **STATUS?:** Ed Thomas to follow up with David Vaughn, the Professor of Practice, who is heading that for Clemson University, and see if we can get something written up on the Practical Community Resilient Project effort and how the NHMA and FEMA-funded CTP is used to support that on an ongoing basis.
- A20: - **STATUS?:** Vince Brown will get information out to us on the Building Codes Report.
- A21: - **STATUS?:** Vince Brown will send a slide presentation on the Culture of Preparedness for us to look at and see where we can further combine what FEMA is doing with NHMA and RNN, and see where Resilience Organization is going
